- I, "identified above", in the perfect use of my faculties, DECLARE, for due legal purposes, that:
- 1. The personal data that were or will be provided to finalize my registration at the event are my total responsibility and / or that of my technical representative, manager, or team coordinator.
- 2. I read, know, accept, and fully submit to EVERYTHING THAT IS ESTABLISHED BY THE ARTICLE OF THE RULES OF THE RACE.
- 3. I am in full physical and psychological condition to train and compete in this RACE, and there is no medical recommendation contrary to my participation.
- 4. I participate freely and spontaneously at the Ultra Trail Amazon event.
- 5. I assume, by my free and spontaneous will, all the risks involved and their consequences for participating in this RACE (which include the possibility of disability and death), exempting its organizers, employees, and sponsors from ALL AND ANY RESPONSIBILITY for any material, moral damages or physicists that I may suffer as a result of my participation.
- 5. I am aware of the penalties and possible disqualification that I may suffer if I breach the regulation or commit a serious fault.
- 6. I exclude my right to complain about such aspects of the race.
- 7. I authorize the use of my image, as well as family and friends, for the purpose of publicizing the event, through photos, videos, and interviews in any means of communication, without creating a burden for the organizers, media, and sponsors.

- 11. I have read all the content and am aware that this Term of Responsibility is an integral part of the Regulation of the Ultra Trail Amazon event, which will take place on November 03, 04 and 05, 2023 in Manaus / AM.
- 12. I have read and fully agree with the event's Regulations, expressly declining that all norms and rules are guided by balance and common sense, and I cannot therefore claim in the future not to agree with them.
- 13. The Organization and the medical team have the right and the duty to remove the athlete from the event if the athlete presents inadequate conditions to complete the challenge.
- 14. I assume to indemnify any amounts resulting from personal or material damages caused by me during my participation in this event.
- 15. I assume all travel, accommodation, food, transfers, insurance, medical assistance, and any other expenses necessary, or from my participation in this event; before, during or after it.
- 16. Representative, coach, or team coordinator, I agree with the competition rules and with my responsibilities specified above, at any time and or place, having nothing to complain about, now or in the future, due to your rules and rules, all being in good faith and strict common sense. I declare that the decision and choice to include and / or exclude participants in said event through the trainer system is the sole and exclusive responsibility of the trainer. The organization is exempt from any decision, personal or direct evaluation with the participant, the trainer being responsible for the accuracy of the information, because, if the participant is aware of his participation or of his registration for the event, the responsibility will be of the same and of your coach.
